- A. Completed application form & worksheet
- B. Written Description of vending activity
- C. Non-refundable \$50.00 fee
- D. Layout of parcel showing everything existing and what is proposed (must showing parking availability)
- E. Location or agreement for restroom facility
- F. Land Owner Authorization (notarized or certified letter or agreement for use of parcel)

**Permit Holder Agreement**

\*Permit holder **SHALL NOT** be allowed to be open thirty (30) consecutive days, however may operate at the same location for up to One (1) year under this permit. (Must be closed One (1) day out of every consecutive thirty (30) day period).

\*Lamar County requires such permit to be valid and proof of such valid permit shall be made available upon request on site from any dually authorized personnel of Lamar County, Lamar County Sheriff Department, Lamar County Tax Assessor, or any other County, State, or Federal Agency or Department. Failure to provide proof shall constitute a violation of the permit and may result in revocation of such permit.

\*This permit shall not constitute a privilege license to operate within Lamar County. Permit is only valid for length and durations as stated by applicant on this worksheet. Lamar County reserves the right to deny, revoke, reinstate, and question the use of such permit at any time upon formal notice as per procedures dictate within the *Zoning Ordinance of Lamar County*.
